Metropolitan Area of Barcelona Environmental Authority (EMA-MAB)



- A local authority created under the Catalan Law 7/1987 of 4 April, which carries out specific public actions in the Barcelona conurbation
 - 33 municipalities
 - Surface area: 585.4 km²
 - Inhabitants: 3,126,294 (2007)
 - Population density: 5,340 inhab/km² (> 15,000 city of Barcelona)

...Introduction to EMA-MAB (Metropolitan Area of Barcelona Environmental Authority)

- **Foundation, government and administration**

- The **Law 7/1987** of 4 April establishes and regulates specific public actions in the Barcelona conurbation and the districts within its sphere of influence
- **Government and administration** of the organization is performed by the Metropolitan Council, a public body which consists of mayors and representatives of all the municipalities (11 representatives from Barcelona, 3 from municipalities of >100,000 inhab. and 1 each from the remainder)



...Introduction to EMA-MAB (Metropolitan Area of Barcelona Environmental Authority)

Matters under jurisdiction of EMA-MBA

- Supply of drinking water is provided by specialized companies
- Water transport through large pipelines and wastewater treatment are carried out by EMSSA, a public corporation
- Treatment of solid municipal waste is made by EMA-MBA and through concessions with private companies

(Environmental Authority of the Metropolitan Area of Barcelona)

Waste water treatment and transport in Metropolitan Area of Barcelona

- More than 250 km of waste water sewers
- 29 waste water pumping stations
- 1 pipe line for sludge (5% water content) 8 km length
- 7 waste water treatment plants and 3 marine outfalls








Demand for Regenerated Water

 - **Quality 2:** Agricultural Irrigation
 - **Quality 3:** Barrier against Saline Intrusion








Reuse at Prat del Llobregat RP. ACTIdisk

- Final solution: ACTIDisk®
- ACTIFLO® (3 x 4.800 m³/h):
 - Max. recirculation: 6 x 110 m³/h
 - Hydraulic load in settler: 120 m/h
- HYDROTECH (2 x 5 lines, 10 unit.):
 - Mesh size: 10 µm.
 - Number of discs: 18 disc/unit.
 - Unitary filter area: 100,8 m²
 - Back-washing pump: 8,4 l/s/unit.






• Disinfection (UV + sodium hypochlorite)



- Four channels of UV, with 400 lamps each make the disinfection of regenerated water
- Additionally, between 2 and 4 ppm of hypochlorite are dosed to guarantee the disinfection during the transport of water



...The Prat del Llobregat Regeneration Plant

• Qualities of Water



Characteristics of the inlet of WWTP

SS > 250 mg/L
BOD > 280 mg/L
N > 60 mg/L
P > 5 mg/L



The outlet of the WWTP, fulfils the quality Standard 91/271.

SS < 35 mg/L
BOD < 25 mg/L
QOD < 125 mg/L
N < 10 mg/L
P < 2 mg/L



After regeneration, water fulfils the Royal Decree RD1620 of reuse for agricultural and environmental uses.(Annex 1, qualities 2.1 , 2.2, 2.3)

< 10 NTU

SS < 20 mg/L

E.c. < 100ufc/100mL

Helminth eggs < 1/10 L



After reverse Osmosis water fulfils the Royal Decree RD1620 of reuse for direct injection/drive to the aquifer .(Anex 1 quality 5.2)



Conclusions

- The maximum regeneration flow in the Baix Llobregat plant is 320.000 m³/day
- The regeneration process made up to this moment, which fulfils the qualities specified in the Royal Decree RD1620/2007, is used for the following ends:
 - Re-establishment of the Llobregat River flow
 - Agricultural irrigation
 - Stabilization of wetlands of ecological/environmental interest
 - Avoidance of salt water intrusion in the aquifer of Delta del Llobregat
- From its starting, in June 2007, to December 2008, an amount of 43 hm³ of water has been regenerated, out of the total of 145 hm³ treated by EDAR, which means 28 %. Its distribution has been:
 - 35,5 hm³ (82%) To re-establish the Llobregat River flow
 - 2,4 hm³ (6%) For agricultural irrigation
 - 4,8 hm³ (11%) To stabilize the wetlands of ecological interest
 - 0,4 hm³ (1%) To avoid salt water intrusion in the aquifer
